

93.7 OUTLAW Online Fair Bundle Sweepstakes

93.7 The Outlaw will be running an online contest that will start Monday, July 13th at 12:00 am and run through Sunday, July 26th at 11:59 PM. Listeners will have the chance to win a pair of tickets to grandstand concerts and events at the Iowa State Fair.

To enter, listeners must go to 937theoutlaw.com and enter under the corresponding contest title page. Listeners must fill out the contest form and submit before 11:59 pm on Sunday, July 26th to be eligible to win. Fifteen winners will be drawn at random from the collected entries and contacted the following week of the contest.

Listeners may only enter once, and multiple entries by an individual, including entries made by using someone else's personal information, will disqualify them. The use of any software or hardware that gives its user an advantage by automating their entries into any contest is prohibited and will disqualify said user. Only one winner is permitted per household. KSTZ-HD2/93.7 The Outlaw will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 guidelines, plus any other rules and restrictions put forth by the event organizers and concert venue.
